URFC contracts with US Forest Capital out of Portland, Oregon for management of our carbon credit certification process.

Biochar Demonstration

In 2017, the Biochar Project actively produced biochar, supported 20 jobs and sold \$14,000 worth of biochar to the community. In addition to providing economic benefits and community outcomes, the project provided environmental benefits by thinning acreage and sequestering carbon. The project hosted multiple tours and generated much local and regional excitement about biochar. The outreach and education extended globally, and the project continues to receive regular, ongoing inquiries and interest. The project provided a replicable model for managing excess woody biomass and increased production to a commercial level.

In 2018, the Biochar Project supported jobs for three part-time contractors and one part-time bookkeeper to support continued sales and marketing. Regional businesses sold \$6,218.80 of biochar on commissions for RFFI. In addition, the biochar committee produced the most comprehensive biomass conversion technology review and evaluation report currently available at www.rffi.org/biochar. The project also conducted biochar marketing report that is available by request and worked with legislators and California State staff to develop incentives for both biochar technology to develop and produce sales.

COMMUNITY

2018 Annual Meeting

The 2018 annual meeting was held at the Lyme Redwood Forest Company Picnic Grounds, north of Fort Bragg, CA. There were 100 community members in attendance. The annual meeting included opportunities for public dialogue and input on the biochar project, restoration activities, and harvesting activities for the year. Awards were presented to two RFFI community volunteers.

Community Advisors

In 2017 and 2018, members of the Redwood Forest Council (RFC), RFFI's 25-member community advisory group, held monthly meetings (nine in 2017, ten in 2018) and attended RFFI Board meetings, Annual Meeting, forest tours and other events. RFC members provided input on strategic planning, organizational development, hiring, forest management planning, timber harvest plans and restoration projects.

Volunteer Program

In 2017 and 2018 URFC formalized our Volunteer program and enlisted support of 200 volunteers. A vast array of community activities took place including engaging students from throughout Mendocino county in forest restoration, and adults in Citizen Science projects.

Usal Lost Coast Hopper

In the fall of 2018, RFFI partnered with Grasshopper Adventure Series to offer a one-day mountain bike event for 150 riders from the Bay Area. In addition to the ride, RFFI staff and volunteers shared the story of the organization at an evening talk and a morning walking tour. This successful event is planned for future years.

Community Events

- Earth Day: In 2018, RFFI staff, volunteers and advisors participated in Earth Day celebration at the Noyo Food Forest.
- Tabling at Paul Bunyan Days: In 2018, RFFI board members and staff participated in Paul Bunyan Days in Fort Bragg over the Labor Day weekend.
- CaliRoots: In 2017 and 2018, CaliRoots Music Festival in Monterey chose RFFI to be a partner for their Redwood VIP tickets by donating to the Plant a Redwood Program to offset their carbon footprint at the festival. RFFI Staff and volunteers tabled at the event and spread information at the festival about the organization.

Ice on Fire

In June 2017, URFC's work was filmed by Tree Media, LLC for "Ice on Fire" a Leonardo DiCaprio
HBO documentary on climate disruption. The URFC carbon project, sustainable forest
management, reforestation program and biochar production and planning were featured in the
final film. URFC was selected as a subject because of these factors as well as for its hallmark
inclusion of Native American practices and participation and the regional community in forest
management.
